# **MINUTES OF LAST MEETING**

The Minutes of the Second Annual Meeting held on Saturday, 9th May 2015 were tabled, approved and signed by the Chairman.

#### FISHERIES MANAGEMENT ORGANISATION

The 3 North Boards had concluded that they should combine in a Fisheries Management Organisation, as proposed under the Wild Fisheries Review. Lord Thurso was very involved in this project, and gave a detailed exposition covering all aspects, from the areas involved to structure of the organisation, including possible costs, and time line. The Chairman thanked Lord Thurso for attending and providing such a detailed Report.

### **CATCHES**

Slight recovery throughout Scotland last year, with Catch and Release on the Helmsdale just over 90%. Counter figures show a declining run in *April* down to 195 for the period 2008 to 2015, compared to 296 in the previous period from 2000 to 2007. The counter is located four miles upstream and on a dry year fish may spawn and not cross the counter. Also some fish may cross back and fore.

### **OPEN DAYS**

These were held from 11<sup>th</sup> to 16<sup>th</sup> January 2016 and the weather was much better. Enjoyed by all and a boost for those providing accommodation in Helmsdale.

### **ELECTRO FISHING**

Bad weather in 2015 meant no surveys, but will attempt a full programme this year, including work for the Forestry Commission.

### **HATCHERY**

Another successful year. Second project year with Professor Gage. He has to obtain funding each year and a 10 year programme is required for conclusions.

### **FISH RUN VERIFICATION**

Verification cameras were installed under Marine Scotland, but not perceived to be a great success. Still to be convinced that operating successfully.

### **TICKETS**

Ronald Sutherland's business is for sale so two new outlets in Helmsdale. Sales are going well.

# **CATCH & RELEASE**

Possibility of using paint marking to show the fish has been released. Tags have been used in other areas.

# **FISH FARM ESCAPES**

Reminder about differences between wild and escaped fish. Interbreeding is a major problem so escapee must be killed and our rule last year was correct.

#### **SEALS**

None in the river last year and none killed.

#### **NETTING**

Jummer.

Scottish Government are proposing to ban coastal netting for salmon for a 3 year period. Scottish Ministers were put in the uncomfortable position of defending netsmen who were killing seals.

# FLOW COUNTRY RIVERS TRUST

This is a Charity registered in Scotland and Its purpose is to promote research and education re. conservation of fresh water species of fish and associated flora and fauna within the Flow Country.

### **CHARITIES**

The Board support the local Pipe Band, provide free fishing days to local Charities, assist the local Angling Club and generally respond to requests from Charities and local organisations.

Danny MacNeil will start in late June 2016 based at the Dorran at Borrobol.

**AOB** The Chairman asked if any news about the <u>Moray Firth Wind Farm</u>. No exact details but it may be built. Regarding the <u>Angling Club</u>, this is going very well and Board thanked for providing funding for equipment. New hut is to be built.
