# **APOLOGIES**

Apologies were received from Sir John Nutting K.C. B.t.

#### MINUTES OF LAST MEETING

The Minute of the last public meeting held on 06 May 2023 was approved.

### **MATTERS ARISING**

There were no matters arising.

#### **ACCOUNTS**

The Audited Accounts for the year to 31 December 2023 prepared by Saffery Champness, Chartered Accountants were tabled, considered and approved.

### **REPORT FOR 2023**

The Report for 2023 was tabled considered and approved.

#### **CATCHES**

Catches for the 2023 season were 1108 on the private beats. There were 105 fish caught up 05 May and it has been reported that around 50 have been caught for the week of this meeting.

### **FLOOD DAMAGE**

It was noted that the river has been altered by the winter spates and that fish are being caught in unexpected locations. There appears to have been damage done to established lies at 4 & 5 below, but it currently too early to assess the extent.

### **CONSERVATION GRADES**

The River has been restored to a Grade One classification.

### **CATCH AND RELEASE**

The return rate for 2023 was again around 97% from the private beats. Slightly lower return rates are reported on the public water.

### RESEARCH

The usual electro-fishing programme, including for the Forestry Commission on the Halladale was undertaken in 2023. As reported by the Manager the young stock in the River are in good health. New lighter equipment has been provided at no charge by Marine Scotland making the task easier. The National electro- fishing programme for Scotland ("NEPS") has had its funding withdrawn and the budget has been reallocated to assist with the capital expenditure.

### PREDATOR CONTROL

The Board obtained a licence to control sawbills which was been exercised. A renewal will be requested. It was noted that Gull numbers are increasing. It was noted that individual estates are free to seek a licence to control black back gulls.

#### **HATCHERY**

The hatchery programme for 2023 had to be abandoned due to a landslide fouling up the hatchery burn. 60 broodstock fish were returned to the river unharmed. A review of the design of the hatchery water intake is underway with a view to prevention of a repeat.

### **RIVER WORKS**

No works have been undertaken since the repair at Jetty Stream. Major changes due to winter flooding appear evident, but it was agreed to monitor and review the need for any repair work. A local contractor is available to undertake any small scale repairs not requiring a CAR licence.

Concern was raised that the newly installed ford at the Kildonan Church may cause issues if the River rises too quickly and it was noted that a bridge may be required.

#### **OPEN DAYS**

These were well attended, but no fish were caught.

### LADIES DAY

This is scheduled for 18 May when ladies only will be permitted to fish on the lower river.

# FISHERY PROTECTION

No poaching events recorded in 2023.

#### **FISH COUNTER**

The Counter remains broken. Funding assistance has been sought but has not proved sufficient for estimate costs. It is hoped that the next round of funding will prove more successful.

# **FISH DISEASE**

No serious threat from Saprolegnia in 2023, but a diseased fish has been seen in recent days. It is hoped that an increase in water temperature will help to remove any threat.

### **AOB**

The condition of the path adjacent to the left bank at the tidal waters on the Lower river remains a concern. The path sits on land not owned by any of the river proprietors who have pledged to make a contribution of £1000 towards its repair when a plan is finalised. It was suggested the Community Council should draw up the plan.
